First sod turned on Church Fields Link Road and Cycle Network in Mulhuddart

The first step has b in the construction of new infrastructure at the Church Fields site in Mulhuddart, as the Mayor of Fingal, Cllr Seána Ó Rodaigh turned the first sod on the project.

he Church Fields Link Road and Cycle Network will create new connectivity to facilitate the development of the Church Fields Masterplan which will deliver housing, retail and community amenities to support the sustainable growth of Mulhuddart. The walking and cycling element of the infrastructure is funded by the National Transport Authority. The region has a population in excess of 2million people and is younger and more diverse than any other part of Ireland with 15% born off the island.

Fingal County Council's Planning and Strategic Infrastructure Department recently appointed Fox Building and Engineering Ltd to deliver the Church Fields Link Road and Cycle Network. The contractor will commence site works from next week and work is expected to last 18-months on this element of the Church Fields plan.

Fingal County Council's Church Fields Masterplan initiative includes new transportation and parks infrastructure funded through the Affordable Housing Fund, from the Department of Housing, Local Government and Heritage, which will enable the delivery of almost 1,000 new affordable and social homes on this publicly owned 37-hectare site.

Work has already started on the construction of 67 homes on a part of the Church Fields landbank that isn't dependent on the new link road and the Mayor was joined in viewing this site by the Tánaiste, Leo Varadkar TD, the Minister for Housing Local Government and Heritage, Darragh O'Brien TD, Minister for Children, Equality, Disability, Integration and Youth, Roderic O'Gorman TD, Minister of State at the Department of the Taoiseach, Jack Chambers TD, as well as Councillors and Oireachtas members from Dublin 15.

There are a further 20 social homes currently under construction within the Church Fields landbank and a Part 8 planning application

for another phase of 300 homes is currently at the public consultation stage. This will include 220 houses and 80 apartments with a tenure mix of 60% affordable purchase or cost rental and 40% social.

The Church Fields Link Road project will feature one of Ireland's first 'cycle-friendly' roundabouts, optimised for shared use by pedestrian, cyclists and motorists. It will be constructed in the middle of the new road which will run south from the existing roundabout on Damastown Avenue to connect with Wellview Avenue. It will also include segregated cycle and pedestrian infrastructure along both of these roads and through parkland adjacent to Church Road.

A new cycle route will be added, linking Damastown Avenue and Church Road Roundabout to Gaelscoil an Chuilinn and Powerstown Educate Together National School on Powerstown Road. This will include construction of new crossings on all arms of the existing roundabout, making walking and wheeling to schools in the area safer for students.

Mayor of Fingal, Cllr Seána Ó Rodaigh, is delighted to see this project commenced. She said: "Today is a great day as work gets underway at Church Fields. Mulhuddart is a vibrant, young and diverse area and Fingal County Council has created a plan for Church Fields that will nurture a healthy community where Active Travel to schools, shops and sports is a way of life."

Minister for Housing, Local Government and Heritage Darragh O'Brien TD, who was present at the sod-turning ceremony, said: "Delivering homes is a top priority for me and this Government. We have very ambitious targets in our Housing for All plan and the development of Church Fields is a great example of how forward planning and co-operation by agencies like the NTA, who part funded this new Link Road and Cycle Network, along with the support from the Department of Housing, Local Government and Heritage and Fingal County Council, can deliver a top class place for people to live and work while also representing value for money in public spending."

Chief Executive of Fingal County Council, AnnMarie Farrelly said: "Church Fields is an example of the cross-departmental collaborative approach that Fingal County Council is taking to the development of our landbanks. The sustainable growth of Fingal is supported by the successful cooperation of departments within Fingal County Council and with external organisations such as the National Transport Authority."

Chief Executive of the National Transport Authority, Anne Graham said: "The NTA are delighted to provide almost €6m to Fingal County Council to fund the walking and cycling infrastructure elements of Church Fields Link Road and Cycle Network. This infrastructure will enable the future residents of this key development area in Dublin 15 to make active transport choices from the outset and is a great example of cross agency collaboration and integrated transport and land use planning. The Church Fields Link Road project will include safe and attractive segregated cycle and pedestrian infrastructure including links to existing local schools."

FINGAL COUNTY COUNCIL **ANNOUNCE ARTISTS' SUPPORT SCHEME**, 2022

Funding increased 100% since 2020

ingal County Council invites applications for the Artists' Support Scheme 2022. This strand of funding, which has increased again this year, allows professional artists to avail of an award up to €5,000 towards travel/professional development opportunities, a residency or towards the development of work.

The objective of the Artists' Support Scheme is to support individual professional artists from Fingal to develop their artistic practice. The award, with a total combined fund of €200,000, is open to practising artists at all stages in their professional careers working in music, visual art, drama, literature & dance. To be eligible to apply, applicants must have been born, have studied, or currently reside in the Fingal administrative area.

The Mayor of Fingal, Cllr Seána Ó Rodaigh commented "This is a very exciting time for the arts as we emerge from a difficult time for the sector. I am confident the 2022 funding opportunity will be of great benefit to our artists and will nurture and encourage artistic excellence in Fingal."

Speaking about the award, Chief Executive of Fingal County Council, AnnMarie Farrelly said "I am delighted to announce the 2022 funding scheme, which enables Fingal based artists to develop their professional arts practice. Last year 89 applicants working in diverse disciplines were awarded a combined total of €150,000 through this bursary strand. The increase in funding again this year reflects the Council's continued commitment to support and invest

Director of Services, Emer O' Gorman said, "Fingal County Council recognises and values the important role of the arts and artists in our society and is very pleased to provide funding to professional artists through this essential scheme."

Aerialist and artist, Emily Aoibheann McDonnell was among the 89 artists awarded under the Artists' Support Scheme in 2021. The funding she received was used towards the research and development of a new ambitious work combining aerial dance and digital technologies. McDonnell stated "Fingal's Artist's Support Scheme allowed me to collaborate with artists Liing Heaney and Rob Mirolo, as well as technical experts, to combine aerial dance and digital technology for a new experimental artwork. The funding allowed us time to work together, enhance our technical expertise and bring together elements of dance, digital art, illustration, animation and technology in exciting, beautiful ways. Although this phase of work focused on research and artistic process, we plan to finish and share our artwork with audiences through film and performance in the future."

The Artists' Support Scheme funding is for projects/initiatives which will take place from 1 May - 31 December 2022. Closing date for receipt of applications is Friday 25 February 2022 at 4pm.

€80,000 in Disability Participation funding for the Not So Different Creative Ability Training Academy in Blanchardstown.

Minister for Children, Equality, Disability, Integration and Youth and Dublin West TD, Roderic O'Gorman has welcomed the announcement that €80,000 in funding will go towards the establishment of a permanent Creative Ability Training Academy in Blanchardstown Library.

he project has been offered funding under the Disability Participation and Awareness Fund 2021, which will see a total of €2.5 million offered to 39 successful projects nationwide to promote community participation and integration for people with disabilities, and raise awareness around UNCRPD. The Fund is provided by the Department of Children, Equality, Disability, Integration and Youth.

The Creative Ability Training Academy will build on the current collaboration between Fingal County Council and Not So Different to establish Ireland's first Neurodiversity Creative Ability Hub. The project aims to promote equality and inclusion of people with disabilities and their families in the community, and improve education and employment outcomes for people with disabilities. The Academy will provide a creative and innovative space where people with disabilities can demonstrate their creative ability and showcase their creative talents to prospective employers and educators.

The Training Academy will provide direct access to the Creative Arts, Media and Film Production Industries, to potential educators

and employers and to community organisations and service providers in a safe, sensory friendly environment.

Welcoming the funding, Minister O'Gorman said:

"I am delighted that Not So Different have been awarded funding for the Creative Ability Training Academy. The Academy will help to break down the barriers many people with disabilities face when accessing education, employment and the creative arts. The Not So Different Creative Ability Hub has been brilliant in helping industry, employers, education institutions and our community to become more inclusive, and this project will further increase awareness, understanding and acceptance of disabilities including neurodiversity.

I am excited to see this project continue to support individuals in harnessing their creative skills, exploring their career opportunities in the creative arts and media, and realising their full potential and the extent of their talents in an environment which supports their individual abilities.

Sports Capital & Equipment Programme

On 11th Feb new capital grants of €144 million is allocated to almost 1,900 applications under the latest round of the Sports Capital and Equipment Programme (SCEP). The SCEP is the primary vehicle for Government support for the development of sports and recreation facilities and the purchase of non-personal sports equipment.

Active Travel Sustainable Transport Measures Grants (STMG) Programme 2022

The National Transport Authority(NTA) has allocated funds to Ireland's local authorities with a view to spending €289 million on walking and cycling infrastructure 2022.

€25,535,000 were approved for the projects in Fingal Councty Council.





LIFFEY VALLEY GREENWAY

I have been leading a campaign to reinstate the objective of a Liffey Valley Greenway in our national transport plans and promote it as a potentially world-class eco-tourism trail. It would be a travesty



if this route along the Strawberry Beds, with the potential to connect the Villages of Leixlip, Lucan, Clonsilla, Palmerstown, Castleknock/ Carpenterstown and Chapelizod was de-prioritised. Fingal has already been allocated €150,000 towards a review of Strawberry Beds Road Mobility Plan. A sensitive Greenway along the Liffey Valley could run from St Catherine's Park to the Memorial Gardens in Islandbridge including Farmleigh Estate/ Phoenix Park and the Silver Bridge.

A new orbital bus service over the M50 called the W4



A new orbital bus service over the M50 called the W4 between Blanchardstown and Liffey Valley Shopping Centres is due to launch during the summer. The route is currently being tendered out and in a recent meeting the NTA told me they are "confident" it will launch as planned.

This is great news and something I campaigned for since becoming a Public Representative. As well as increasing direct connectivity between Blanchardstown SC and Liffey Valley SC, it will connect retail and high employment areas all the way to

Tallaght Shopping Centre via places such as Ballyowen Shopping Centre, Grange Castle and Kingswood.

This is no replacement for the 239 that connected the Liffey Valley and Blanch Shopping Centres via Lucan Village. I have raised concerns about splitting the old 239 into two routes (L52/51) and the impact it's had on previous users. I have arranged a follow up meeting with the NTA for early March to discuss this matter further with them.

A step forward in campaign to secure the future of Hartstown Community Centre

I want to say thank you to the Hartstown Board of Management who have worked tirelessly to keep the doors open these last three years.

The Centre requires significant investment and refurbishment, beyond the reach of community fundraising alone, but ownership has been a barrier to accessing public funds. Discussions to transfer the ownership to Fingal County Council have now begun and I will continue to push the need for urgent investment in the Centre.

Phoenix Park

Before Christmas I sought an update on the recommendations from the Phoenix Park Transport and Mobility Options Study, which has subsequently been publicly announced. I want to bring your attention to:

- Speed limit is set to drop from 50kph to 30kph from 28 February.
- The temporary traffic cones currently on Chesterfield Ave will shortly be replaced by cycling dividers until permanent cycle lanes are developed. Please note €150,000 has been budgeted by Fingal County Council and €50,000 by the NTA for the design of the cycle route from Blanchardstown to the Phoenix Park via Farmleigh.
- From 28 February the following traffic changes will be implemented for a 9-month pilot study.
 - A one-way-system on North Road, in the city direction. The North Road will be temporarily closed from 23 to 28 February to facilitate works, including the installation of bollards, new road markings and directional signage.
 - A cul-de-sac on Upper Glen Road. The Upper Glen Road will temporarily closed from 21 to 28 February in preparation for the changes too.

PARKING & PUBLIC TRANSPORT - Preparation for the promised Parking Strategy has thankfully now begun and I look forward to a public consultation. The number of car parking spaces. has dramatically reduced, while following the relaxation of Covid restrictions, visitor numbers will rise again at Dublin Zoo. A Parking Plan and better, incentivised public transport must be in place to cope. I have asked for an update on the proposed Bus Pilot from Heuston to Broombridge Stations via Cabra Gate.

Ashtown Gate Update

Dublin City Council has agreed to undertake a technical assessment of Ashtown Gate thanks to a motion Clir Colm O'Rourke put down on my request. There must be a safer way to coordinate traffic here that doesn't involve making the Gate one-way. A DCC Area Engineer will make a recommendation to DCC following the assessment.

I am giving a brief update on some issues which I have been working on. Please don't hesitate to contact me if you have any queries or I can be of any assistance.

PROTECT DANU COMMUNITY SPECIAL **SCHOOL AND RATH** DARA CC

The Department of Education is planning to locate Danu Community Special School, which was established to provide for children with autism, permanently within the existing building for Rath Dara Community College. While a temporary location for Danu is necessary, the permanent plan fails to meet the essential needs of the children in Danu Community Special School and severely reduces the facilities and space available to students in Rath Dara. This is a disastrous plan which undermines two school communities: already it has led to the building of a wall to separate the two schools which fails to meet basic standards of inclusion for children with additional needs.

I have called on the Department of Education and Dublin and Dun Laoghaire Education and Training Board to ensure that Danu secures a dedicated, purpose-built building on its own site, while Rath Dara is allowed to develop and expand as a school at its current location.

DRAFT FINGAL **DEVELOPMENT PLAN**

The draft Development Plan for 2023-29 will be issued by Fingal Council in mid-February and will be put out for public consultation for a ten-week period until early May. So far, I have requested the following changes to the draft text, which are being incorporated in the draft Plan:

- A master plan to protect the Old Schoolhouse, Clonsilla and ensure sensitive development at this location should be adopted within two years of the commencement of the new Development Plan. A time limited commitment is important as a Master Plan for the Old Schoolhouse was proposed in the current Development Plan but never implemented. Cllr Mary McCamley and I are also lobbying Fingal Council to buy the Old School House so that it can redeveloped as a cultural and heritage amenity for Dublin 15.
- The Council has made a commitment to include community and voluntary groups, including residents' associations and Tidy Towns groups, in the process of consultation for Urban Framework Plans for Blanchardstown, Castleknock and Clonsilla, which are to be prepared during the lifetime of the Development Plan. Often such consultations tend to be dominated by developers or their agents.
- A new objective is being included in the draft Plan requiring Build to Rent applicants to show that 'there is not an over-concentration of Build to Rent Accommodation within an area, including a map showing all such facilities within 1km of a proposal.' This will allow greater space for a mix of housing types and tenure, including more houses, family homes and owneroccupied housing, in new developments.



HOUSING SCHEME AT CHURCHFIELDS

Fingal Council recently held a public consultation on the latest phase of the planned housing development at Churchfields in Mulhuddart, which will deliver 220 houses and 80 apartments: this is a very welcome plan for new housing which will go to the Area Committee and full Council for approval in March. The scheme at Churchfields will ultimately provide 1000 new housing units, consisting of affordable and social housing. I have submitted a motion requesting that a not-for-profit childcare service be provided in Churchfields to meet the need for affordable childcare in the area.



UPDATE ON DEVELOPMENTS IN CLONSILLA

I recently held an online public meeting to get feedback from residents on several proposed developments in Clonsilla.

- The application for an Aldi foodstore and residential development on Weaver's Row was rejected by Fingal County Council on 3 February as contrary to proper planning and sustainable development of the area.
- Bartra Property has made an appeal to An Bord Pleanála against Fingal Council's
 decision to refuse a 99-unit, five storey development on Porterstown Road. I have
 made a submission objecting to the appeal due to the overwhelming character of the
 development, lack of consistency with housing in the Village Porterstown and Clonsilla
 Village and the lack of connectivity for pedestrians and cyclists as a result of a single,
 unsafe access point on Porterstown Road.
- The proposed Strategic Housing Development at Kellystown fails to include decent social and community infrastructure such as schools and community centres, does not protect high value trees and hedgerows and fails to make any provision for St Mochta's Football Club. I have made a submission to An Bord Pleanála to point out that the SHD is contrary to the recently adopted Kellystown Local Area Plan. We need housing in Kellystown, but it has to be balanced, sustainable development supported by strong social and community infrastructure.



BÁC LE GAEILGE

Government Chief Whip and Minister of State for the Gaeltacht and Sport, Jack Chambers, has approved funding of €325,000 for Conradh na Gaeilge to establish and develop the BÁC le Gaeilge project between 2021 and 2024.

These include early education services, gaelscoileanna and Gaelcholáistí, Irish language organisations, two radio stations broadcasting in Irish, Na Gaeil Óga GAA club, third level courses in Irish and many other establishments.

Conradh na Gaeilge, in partnership with Dublin City Council, has set out a programme of activities to ensure that the language is heard and seen more around Dublin city. 

Funding offered for projects across all 31 Local Authorities to promote community participation and integration for people with disabilities, and raise awareness around UNCRPD

Minister of State with Special Responsibility for Disability, Anne Rabbitte, recenty announced that 39 projects across all 31 Local Authorities will be offered a total of €2.5 million under the Disability Participation and Awareness Fund (DPAF) 2021.

he purpose of the Disability Participation and Awareness Fund, which was established by Minister Rabbitte under Budget 2021, is to provide funding to support the participation of people with disabilities in local activities, to help remove barriers to community involvement and to support the promotion and implementation of the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) in communities. In 2021, this funding is being provided through Local Authorities.

Projects approved this year will:

- Promote the rights of people with disabilities
- Assist in removing barriers to participation in local and community life
- Raise awareness of the UNCRPD within communities and local authority staff and elected members

Further funding calls will issue in 2022, and the scheme parameters will be adjusted based on the learning arising from the initial call this year. Targeting community groups directly next year, the Minister hopes to build on the momentum established in 2021 and seeks to focus on further supports for community participation and integration.

Announcing the projects receiving funding, Minister Rabbitte said: "I am pleased to be able to launch the first year of the Disability Participation and Awareness Fund, and look forward to future calls as we move forward. I know that there was huge interest in this Fund and that speaks to the need for practical and effective measures to support the integration of persons with disabilities into our daily community life.

"Working in partnership with Local Authorities and community organisations supported by this Fund, we will be able to make progress on breaking down barriers to participating in local activities and making local amenities more accessible. Much will be done through the projects that are receiving funding, and there is much more than we can continue to achieve through this Fund over the coming years.

."The provision of this funding speaks to this government's commitment and willingness to make our local places and spaces accessible to all. Reflecting on the applications received, Local Authorities made a significant number of applications for capacity building and awareness raising within their organisations and it is my intention to engage with Local Authorities over the coming year to address these needs in a structured format.

"We will use the learning from this year's fund to help us target measures that will make practical changes to participation and integration with the everyday life of our communities," concluded Minister Rabbitte.

The Disability Participation and Awareness Fund 2021 was announced on the 18th October this year.

Applications were invited from Local Authority applicants around key themes to support the participation and inclusion of disabled people in local communities: Participation in community life i.e. sports, the arts, community groups, and so forth; accessible information and shared public places;

UNCRPD Promotion; and Disability Awareness and Capacity Building.

It was open to local authorities to partner with local and community organisations in delivering on projects. Projects were assessed against eligibility criteria and then scored on a number of areas, including the extent to which proposed projects aligned with the stated aims and goals of the Fund.

The UN Convention on the Rights of Persons with Disabilities was adopted in 2006. Ireland signed the Convention in 2007 and ratified the Convention in 2018. The purpose of the Convention is to promote, protect and ensure the full and equal enjoyment of all human rights and fundamental freedoms by all persons with disabilities, and to promote respect for their inherent dignity.

Fingal Community Groups invited to apply for Community Activities Funding

Community and voluntary groups in Fingal are invited to apply for funding under the 2022 Community Activities Fund.

he Community Activities Fund (CAF) is a once-off fund that provides grants to assist community and voluntary groups with facilities upgrades, equipment purchase and running costs. The CAF is funded by the Department of Rural and Community Development with Fingal allocated €301,042 in funding for groups across the county. It was launched before Christmas at a national level by the Minister for Rural and Community Development, Heather Humphreys TD, and the Minister of State with responsibility for Community Development and Charities, Joe O'Brien TD.

The CAF can support groups, particularly in disadvantaged areas with: Operating and running costs such as utility bills, rental/lease costs and insurance bills.

The cost of repairs and improvements to facilities, purchase of I.T. equipment, furniture, tools, signage, training equipment etc.

The CAF is administered by Local Community Development Committees (LCDCs) in each Local Authority area. It is part of the wider Community Enhancement Programme, which has funded over 8,000 projects in urban and rural communities throughout Ireland since first being launched in 2018.

Applications are now being sought from community and voluntary groups in Fingal for grants up to a maximum of €15,000 with a closing date for applications of Friday, February 18, 2022 at 6:00 PM

Speaking about the Community Activities Fund, Mayor of Fingal, Cllr. Seana O'Rodaigh said: "The Community Activities Fund can be an important support to community groups in Fingal to help them improve their facilities and fund operating costs. Fingal County Council is pleased to offer this support in acknowledging the central role community groups play in the wellbeing of people throughout the county. The programme is a valuable response to local needs and can help local groups deliver many improvements in their own areas."

Commenting on the announcement, AnnMarie Farrelly, Chief Executive of Fingal County Council said: "The work of the community and voluntary sector is highly valued by Fingal County Council. The Community Activities Fund will assist community groups with the valuable work they do within our communities. I would advise community groups to examine the CAF and avail of the opportunity to apply for funding if it is relevant to their activities."

Welcoming the new CAF Scheme, Emer O'Gorman, Fingal County Council's Director of Economic, Enterprise, Tourism and Cultural Development, said "There is substantial funding available under the CAF which compliments other funding available from Fingal County Council. This funding option has the potential to add significantly to the activities of community and voluntary groups and I would encourage groups to apply where possible"

Declan Ryan, Chief Officer of the Fingal Local Community Development Committee added: "The Community Activities Fund comes from within the Community Enhancement Programme group of funds. These funds have been availed of widely by community groups in Fingal in recent years, which has resulted in valuable funding being distributed to groups in disadvantaged areas in particular. The new CAF has the added benefit of allowing applications for both capital costs and operating costs. This added flexibility is very welcome. The Fingal LCDC looks forward to supporting the delivery of this scheme."

€25.5M FUNDING FOR ACTIVE TRAVEL IN FINGAL

Fingal County Council has welcomed the announcement by the Department of Transport, that €25.5m in funding has been granted to 44 Active Travel projects across Fingal.

ctive Travel is part of the commitment of Fingal County Council to tackle climate action. Active Travel is travelling with a purpose using your own energy, which usually means walking or cycling as part of a purposeful journey, and the Council's objective is to build Active Travel into everyday life as part of normal daily routines. Since the creation, in late 2019, of an Environment, Climate Action and Active Travel Department significant progress has been made in developing the Active Travel agenda. Fingal County Council was the first local authority in Ireland to create such a department and has invested heavily in resources toward its development.

The Minister for Transport Eamon Ryan confirmed that the National Transport Authority (NTA) has allocated these funds as part of a national annual spend of €289 million on walking and cycling infrastructure in 2022.

Projects to receive funding include the Skerries Active Travel Plan, St. Cronins Road, the Broadmeadow Way, Seatown Roundabout and Rivervalley and Rathingle in Swords, locations in Balbriggan including the Harry Reynolds Road, Balrothery village, Rush South Beach and New St Malahide. 44 projects in Fingal have benefitted from this NTA funding.

Mayor of Fingal, Seána Ó Rodaigh, welcomed the funding. "Fingal is a young and rapidly growing County. Our sustainable growth can be supported by Active Travel, which will serve healthy communities by creating infrastructure that helps people to commute to school, work or just to their local shops by walking and wheeling."

Minister Ryan said "It is important to accelerate delivery of sustainable transport modes as we come out of the majority of Covid restrictions. It is vital that we do not allow a return to gridlock as we come out of the pandemic. We need to use the switch to remote working as an opportunity to reallocate road space to create


a safer and more efficient transport system.

Chief Executive of Fingal County Council, AnnMarie Farrelly, says Active Travel remains a major priority for the County. "Fingal continues to grow and as we move out of the early phase of the Covid pandemic we can see once again a real need for new transportation options in our locality. Our Active Travel team has been working diligently to deliver infrastructure that offers meaningful alternatives to the private car and will continue to do so with this funding now in place. With 44 projects in action under this funding alone we are making great progress in the change to Active Travel and look forward to continuing this transformative work."

David Storey, Director of Services for Environment, Climate Action and Active Travel at Fingal County Council says this funding is vital to the future of the county. "This funding from the NTA will help us to deliver essential infrastructure to the areas that need it most. It is our mission to improve sustainable and safe travel across Fingal. Active Travel should be the first choice for journeys under 5km and we are working to make that choice convenient, safe and inclusive by delivering a multitude of innovate schemes. This funding recognises the hard work and investment required to change how we travel, and we are very happy to receive it."

With the Government investing almost €1 million per day nationally on walking and cycling projects it is clear that Active Travel remains a key priority at local and national level. Fingal County Council is working to build Active Travel into everyday life as part of normal daily routines. Active Travel has the potential to transform our communities and positively impact our climate and Fingal County Council will achieve behavioural change by providing best in class infrastructure, policies and amenities that prioritise walking and wheeling for the people of Fingal.

GARY MOORE, HIS GUITAR AND THE BLUES

Following on from our biographies of both Rory Gallagher and Phil Lynott, we present the third prong in the trident of old school Irish Rockers, Robert William Gary Moore.

cknowledged as one of the finest musicians that the British Isles has ever produced, and with a career that dated back to the 1960s, there were few musical genres that Gary Moore had not turned his adroit musical hand to.

Gary Moore was born in Belfast on 4 April 1952, the son of Winnie, a housewife, and Robert Moore, a promoter who ran the Queen's Hall ballroom in Holywood. He grew up near Belfast's Stormont Estate with four siblings. He credited his father for getting him started in music. When Moore was six years old, his father invited him onstage to sing "Sugartime" with a showband at an event he had organised, which first sparked his interest in music. His father bought him his first guitar, a second-hand Framus acoustic, when Moore was 10 years old. Though left-handed, he learned to play the instrument righthanded. Not long after, he formed his first band, The Beat Boys, who mainly performed Beatles songs. He later joined Platform Three and The Method, amongst others. Around this time, he befriended guitarist Rory Gallagher, who often performed at the same venues as him. He left Belfast for Dublin in 1968 just as The Troubles were starting in Northern Ireland. A year later, his parents separated.

Gracing the line-ups of several notable rock bands, Thin Lizzy, Colosseum II and (The Original) Skid Row, in his time, he also established himself as a world-class guitarist, with few equals. Like many others, he was turned on to rock and roll first through hearing Elvis Presley, and then via The Beatles. Seeing the likes of Jimi Hendrix and John Mayall's Bluesbreakers (a band once graced by the Immortal talents of Eric Clapton) in his hometown in the mid-60s opened up to him the rich world of The Blues. Hearing the art of the blues guitar performed by such lauded exponents as Peter Green fired Moore's nascent talent, and it wasn't long before he was being hailed as a teen musical prodigy. Indeed, it was Green himself who helped foster Moore's career, a debt that was repaid handsomely when Gary cut his warm and heartfelt tribute to his mentor, the 'Blues For Greeny' album, released in 1995.

Gary's first band of note, the power trio Skid Row, secured a record deal with the CBS label in 1970. By this time, Gary had moved to Dublin, and befriended a certain Philip Lynott, who filled the vocal role with Skid Row until shortly before the CBS deal was signed. Gary cut three albums with the band, and toured the USA supporting The Allman Brothers Band, and Mountain amongst

others, before he left Skid Row to embark on a solo career. This proved short-lived, as Gary was soon to reunite with Phil Lynott as replacement for Eric Bell in the Thin Lizzy line-up. Although he was in the band for a relatively brief tenure, he would re-join their ranks following the departure of Brian Robertson in 1977, and again, finally as a full band member, for the 'Black Rose' album and tour in 1978.

In 1979, Gary's solo career began in earnest with the evocative hit single, 'Parisienne Walkways', which pitched Gary's tasteful, blues-soaked lead guitar with a moody Phil Lynott guest vocal. The single reached the UK Top Ten in April of that year, and the subsequent album, 'Back On The Streets' was similarly well received. The late 1970s and early 80s were characterised by Gary's restless search for the best musical settings for his talents; a reunion with Phil Lynott produced the powerful 'Out In The Fields' hit single (1985). He explored his Celtic roots on the album 'Wild Frontier' (1987), but it was with the 1990 album, 'Still Got The Blues', that Gary arrived at a rich musical vein within which his creativity could flow freely. This and its successor, 'After Hours' saw cameo appearances from the likes of such Blues guitar greats as Albert King, BB King, and Albert Collins, and it is a testament to Gary's own remarkable talents that he more than held his own amongst such august company. In 1994, Gary worked alongside Ginger Baker and Jack Bruce in the band BBM, cutting one accomplished album, before resuming his solo career. The, Back To The Blues' (2001) album saw him revisit the blues with renewed vigour and determination, after the more experimental 'Dark Days In Paradise' (1997) and 'A Different Beat' (1999) albums. A ten-track collection that mixed excellent Moore originals, with gritty and intense covers of standards. But, in the tradition of keeping his fans and critics guessing, 2002 saw Gary Moore crashing back onto the music scene with what had to be his heaviest collection of songs since the late 1980's, once again forcing people to reassess any opinions and preconceptions they might have had of him. That time round though, Moore had decided to share the limelight, joining forces with ex-Skunk Anansie bassist Cass Lewis and Primal Scream drummer Darrin Mooney to form 'Scars', a true power trio in every respect.

The 'Scars' album was completed in early 2002 and that line-up, then went on to record the 'Live at the Monsters of Rock' (2003) live CD and DVD, which featured the band's set as performed on two separate nights on the UK Tour in May



2003. That live set encompassed a diverse range of material, from across Gary's playing career. 2004, saw possibly the rawest album yet, with 'Power of the Blues'. The 10-track set, recorded mostly live in the studio, ranged from the hard rock/blues of the title track, via the upbeat swing of "Can't find my baby", to the haunting "Torn Inside".

Taking time out in August 2005, for a brief reunion with former Thin Lizzy band members including Brian Robertson whom he had replaced in 1977, for a one off concert in Dublin, to mark the occasion of Phil Lynott's birth. The evening was filmed for the 2006 DVD release, 'Gary Moore and Friends, One Night in Dublin, A Tribute to Phil Lynott'. Eric Bellas well as ongoing Lizzy member Scott Gorham were also on hand. The concert was simply called "The Boy Is Back in Town", with the "One Night in Dublin" title a change made for the DVD. On 21 April 2009 it was also released on Blu-ray format.

The show was typical in several ways of both Thin Lizzy shows and Gary Moore ones. As always with Thin Lizzy, "Cowboy Song" was followed by "The Boys Are Back in Town", and "Whisky in the Jar" is part of the encore. When Moore recorded "Don't Believe a Word" as a solo artist he played the song in its original slow blues arrangement; here he begins performing his version before switching mid-song to the faster Thin Lizzy-style rock song. As is always so with Moore, he closed with "Parisienne Walkways". Robertson, Gorham and Bell only performed songs they originally performed with Thin Lizzy. The DVD also contains the unveiling of a statue of Phil Lynott in Grafton Street, Dublin earlier that day, and rehearsals and interviews with Thin Lizzy members who featured in this concert.


With his 2007 studio album "Close As You Get", Gary continued in a direction not too dissimilar from "Old, New, Ballads, Blues", released in 2006. Mixing original tunes with some interesting blues covers that Gary had rediscovered, whilst researching for his award winning radio series, "Blues Power", for Planet Rock (UK based digital/internet radio station).

September 2008 saw the release of what would turn out to be Gary's last studio album, "Bad for you Baby". Again, a powerful collection of tracks, mixing original material and selected blues :

covers. After being on the road for most of 2008 and into 2010 with the "Blues" line up of the touring band. Gary returned from a tour of Russia and the Far East, and decided to reunite with his old sparring partner from the rock line up's of the 1980's, Neil Carter. The plan was to put together a "Rock" line up and dust off a selection of tracks from the mid to late 1980's. Adding Jon Noyce, (ex Jethro Tull/Sessions) on bass, some one who was also part of the, "One Night in Dublin" Tribute DVD in 2005, and Darrin Mooney (Primal Scream/Sessions) on drums, who was no stranger to the touring and recording line during the late 1990's and early 2000's. This line up, hit the road in May of 2010, performing a live set based around a selection of tracks from Gary's "Rock Years." of the 1980's. This proved to be a real treat for fans, old & new, as many would have not heard Gary play these songs live, either for a very long time, or in many cases, at all. In addition to the older tunes, a number of new "Celtic Rock" style tracks were included in the show, which went down very well with the live audiences. Tracks, which Gary was planning to record and embellish, on his next studio project. A project that was ready to start when Gary returned from a short holiday break. Unfortunately, that was not to be, as Gary passed away in his sleep in the early hours of February 6th, 2011, in Estepona,

After being such a "force of nature" in the guitar-playing firmament, as part of a professional career that began when he was only 16. He leaves behind a huge hole for many, not just his close family and friends, but guitar fans around the world. Of all the many tributes paid since Gary's passing, maybe this one, from Gary's friend and musical collaborator, Don Airey, might sum up the best of most people's thoughts of Gary: "At the 1984 Donington Festival during the long solo in "Empty Rooms" the previously restless crowd went so guiet, you could hear a pin drop - everyone back and behind stage stopped whatever they were doing and just stood to listen open-mouthed. His artistry touched thousands of people over the years, not least those of us lucky enough to have shared a stage or a recording studio with him. Sleep tight old mate, you'll be sorely missed."


this before in your circle or family, so go and ask them for help.

Church Fields housing welcomed – Paul Donnelly TD

Paul Donnelly, Sinn Féin TD for Dublin West, has welcomed the beginning of the housing development by Fingal County Council on Church Fields in Mulhuddart.

he development will include 300 mixed housing units (2,3- and 4-bedroom houses and 1-, 2- and 3-bedroom Apartments). It will also include community facilities such as a creche, a dedicated Community centre and 2 retail

This development is a positive move but also hugely overdue, five years ago in 2017, Fingal County Council brought forward a plan to build upwards of 1,000 housing units on a council owned plot of land in Mulhuddart/Damastown.

Sinn Fein councillors, including local area councillor Cllr. Breda Hanaphy, have supported this plan from day one and we are eager to see social, affordable, and cost rental houses come on stream.

Unfortunately, less than 100 homes have been built as part of the scheme so far. There have been no affordable homes delivered due mainly to the failure of the Fine Gael led and Fianna Fail supported government to put together an affordable homes scheme.

Sinn Fein will be demanding that funding will be put in place to deliver genuine affordable homes and will resist efforts to sell of any of the land to private developers for homes that will be sold at market prices.

We also look forward to the delivery of the new linear park, youth and community facilities along with revamped and upgraded open spaces in Wellview, Parslicktown and Dromheath.

There should be no further delays to this scheme.

We are still in the midst of a housing crisis and while these welcomed homes are been delivered under the "housing for all" scheme this is not housing for all, but more of the same failed Fine Gael and Fianna Fail housing policy that created this crisis in the first place.

It is now very clear that there will be little if any increase in direct capital investment by Government in social and affordable homes between now and 2025, which means rents and house prices will continue to rise and supply will continue to lag behind demand.

There is nothing plan to tackle rising rents, however there is plenty for developers including the controversial shared equity loan scheme which will inflate house prices further.

The target of 33,000 new homes by 2025 includes just 10,000 social homes, 2,000 affordable purchase and 2,000 cost rental homes, this means that social and affordable housing delivery in 2022, 2023 and 2024 will be broadly what was in the pipeline before his plan was produced

In fact, the 90,000 new social homes promised by 2030 are 10,000 fewer that what was promised under Rebuilding Ireland and the National Development Plan.

"This plan is a huge, missed opportunity and the reality is it will do very little to help those currently struggling to rent or buy. It is clear that in the battle between Fianna Fail and Fine Gael, that delayed the launch of today's plan by over a month, Fine Gael has won, and housing policy is still being dictated by Leo Varadkar's party"

RADICAL RESPONSE NEEDED FOR HOW WE TACKLE VIOLENCE AGAINST WOMEN

On 12th January, this year, a young woman left her house for a run along the Grand Canal at Cappincur, just outside Tullamore, County Offaly. She never made it home. Her name was Ashling Murphy.

n 20th January, last year, a woman was stabbed while walking home from work in the IFSC, in Dublin City. She died two weeks later on the 3rd February. Her name was Urantsegseg Tserendorj. Two women killed, only a year apart. Two women killed by men. There are thousands of victims of men's violence against women in Ireland, and the devastating impact of that ricochets across society leaving women feeling unsafe in our society.

Violence against women in numbers

According to a 2014 European Union Fundamental Rights Agency survey, one in three women have experienced psychological violence by a current or former partner.

12% of Irish women and girls over the age of 15 have experienced stalking.

And more than 200 women have died violently in the Ireland in the last two decades.

These murders, and the repeated acts of male violence that are happening to women and girls across Ireland, demand a comprehensive and strategic response from the Government.

Government action

As part of the Programme for Government, we recognised the epidemic of domestic, sexual and gender-based violence (DSGBV). We recognised the fragmented nature of the State's responses to this, and commissioned an **audit** of how responsibility is shared among different government departments and agencies. This audit was conducted to inform proposals on how we can ensure the State responds to DSGBV and the needs of victims of violence in the most effective way possible.

We agreed that the Department of Justice will be the lead Department with responsibility for responding to DSGBV, and we will coordinate the transfer of policy, accommodation and services to that Department. This addresses a significant challenge, which could make a huge difference in how victims of violence are supported, and is something domestic violence services have been advocating for for many years.

In Budget 2021, I significantly increased funding for domestic :



violence services in recognition of the constraints on services, particularly in the context of COVID-19, and have maintained this level of funding for Budget 2022.

Tusla have undertaken an accommodation review of refuge spaces and availability of domestic violence services. This comprehensive mapping will be published soon and will help to inform where the Government needs to purchase accommodation spaces for new or expanding refuges across Ireland. Refuges, like Sonas in Dublin 15, provide vital accommodation for women and families when they first flee an abusive situation.



In the coming months, I will be introducing a statutory entitlement to paid leave for victims of domestic violence. This will ensure that those in abusive relationships are supported to leave their abusive partners, without the fear of losing income from their job.

Last year, the Government introduced Coco's Law which criminalises the taking, publication, or sharing of intimate images without the person's consent – also known as image-based abuse. This was passed into law in in December 2020.

We will also introduce new laws to criminalise stalking, and ensure it includes online and all modern forms of communications. Stalking has a very serious and long-lasting impact on a victim, and it is crucial our laws on this issue reflect that.

The Government's **Hate Crime Bill** is also moving its way through the Oireachtas. This will bring tougher sentences for crimes that are motivated by prejudice or hate, based on a person's gender, or other protected characteristic. Crimes like assault, coercion, harassment, or threats to kill or harm a woman will be included under this new law.

Zero-tolerance for violence against women

Government has a leadership role in eliminating all forms of violence against women and, importantly, in ensuring victims of violence feel safe, secure and supported. We have named this an epidemic, and must now act accordingly.

Soon, the Government will publish its third National Strategy on Domestic, Sexual and Gender-based violence. It will be structured around four pillars: prevention, protection, prosecution and coordinated policies. It will include substantial actions to tackle this issue in all sections of society.

Men must also stand up and play a role in changing the social and cultural attitudes in our society.

We need to make it known that misogyny in the home, in the workplace, in friend groups, and in public life, is unacceptable because we know it fuels violence against women.

Enough is enough. The price of doing nothing, or doing too little, is too high.

Fingal looks to save on annual energy costs and reduce carbon emissions

Fingal County Council has taken another positive step in its efforts to reduce its energy consumption by engaging an energy services company to deliver significant energy efficiency upgrades for the Civic Offices in Blanchardstown and County Hall in Swords.

awyer Sustainability, which has a multi-disciplinary team of highly qualified Building Services and Green Energy Engineers, has been awarded a €1 million contract to design, install and maintain a suite of energy efficiency measures. The primary measures for both buildings include the installation of a solar photovoltaic (PV) system and full upgrades of the lighting, boiler, air handling and building management systems.

The contract, which is for nine years, will create total energy savings of 1.3GWhs per annum which represents 37% of total energy consumption at present.

Fingal has already delivered energy reductions of 39%, beating its initial target of reducing energy consumption of 33% in the decade to 2020. This has also seen them manage to achieve ISO50001 Energy Management Certification for its energy management systems. The Council is now tasked, under its Climate Change Action Plan, ith reducing its 2009 energy consumption levels by 50% by 2030.

This contract is one of four similar energy performance contracts that Codema, Dublin's Energy Agency, has facilitated on behalf of the Dublin Local Authorities in the past five years.

The Deputy Mayor of Fingal, Cllr Daniel Whooley, said: "This project will play an important role in achieving the climate and energy efficiency targets set out in Fingal County Council's Climate Change

Action Plan 2019 -2024. It will act as an exemplar for other public bodies across Ireland, as well as for businesses in Fingal who want to become more sustainable."

AnnMarie Farrelly, Chief Executive of Fingal County Council, said: "This is a natural next step for us in our efforts to lead the way in terms of Climate Change Action within Fingal. With the help of Codema, we have already met our energy consumption to 2020 and are firmly focused on meeting our 2030 target. The team from Lawler Sustainability have a big role to play in helping us achieve major reductions in energy consumption and CO2 emissions."

Daniel Ring, Managing Director of Lawler Sustainability said: "We have experience of successfully working with other local authorities on energy performance and will be implementing a model that has a proven track record which maximises environmental impact while simultaneously generating commercial savings."

Joe Hayden, Senior Executive Engineer with Codema, said: "The Energy Performance Contract model is very successful and is well-established in countries such as Germany, Austria and the Czech Republic, so it is great to see it continuing to strengthen its foothold in Ireland. Energy Performance Contracts not only provides the Council with the security of guaranteed energy savings, it also saves on the cost of maintaining these upgrades over the lifetime of the contract."



School Zone works commence at St. Philip the Apostle JNS **Coolmine**

Fingal County Council's Active Travel team has confirmed that work has commenced at St. Philip the Apostle Junior National School as of January 19, 2022.

his School Zone work is part of ongoing Protected Cycle Lane works in the Coolmine area and Fingal County Council will be carrying out works in front of the school for an estimated period of 8-10 weeks.

The works being undertaken have been designed in line with standards outlined by the National Transport Authority. Works include footpath upgrades, the placement of an epoxy surface (a coloured surface) along the road and additional signage. New bollards designed to look like pencils will also be installed as a visual reminder to motorists that they are in a School Zone and must drive :



accordingly, slowing their speed and remaining vigilant for children crossing. Finally, a new zebra crossing will also be constructed to the front of the school, with evergreen rain gardens as a key feature of the landscaping.

Fingal County Council has sequenced works to ensure there is no disruption to access for staff and students during the construction period and to minimise the impact to motorists in the area.

Evergreen rain gardens are ground level flower beds built into the footpath. These green features will enhance the streetscape with year-round colour, make use of rainfall for natural watering where light flooding might usually occur and have the added benefit of preventing parking on the footpath.

Road safety and the creation of safe environments for children and adults to walk or wheel to schools is a key priority for Fingal County Council. This programme of work is an important development for the school and local community in Coolmine.
